FIRST NOTIFICATION

CALL FOR ELECTION OF REPRESENTATIVES OF BLACK, AFRO-COLOMBIAN, RAIZALS, AND PALENQUERAS COMMUNITIES BEFORE THE HIGH-LEVEL DEPARTMENTAL CONSULTATIVE COMMISSION AND THE NATIONAL PEDAGOGICAL COMMISSION

In compliance with the provisions of Articles 2.5.1.1.5 and 2.5.1.1.9 of Decree 1640 of December 14, 2020 and in accordance with the provisions of the External Notification with filing number OFI2022-14088-DMI-1000 of July 8, 2022, issued by the Ministry of the Interior, the Government of the Departmental Archipelago of San Andres - Secretariat of Social Development, is convening the representatives of the Community Councils, Grassroots Organizations and Forms of Organizational Expressions of Black, Afro-Colombian, Raizals Communities and Palenqueras, to participate on behalf of said communities in the election and/or formation of the Departmental Consultative Commission of SAN ANDRES, PROVIDENCE, AND SANTA CATALINA.

This election will be held in a public session, chaired by the Governor or his delegate, on September 20, 2022, starting at 8:00 a.m. at the Departmental Government facilities located on the Newball Avenue, Coral Palace Building.

The Assembly of this Consultative Commission, by virtue of the provisions of Art. 2.5.1.1.8 of Decree 1640 of 2020 and in harmony with the provisions of the aforementioned External Notification, will be composed as follows:

- The legal representatives or the delegate of the Community Councils with collective title, or in the process of awarding title, registered in the municipal or district mayors, by virtue of transitory Article 56 and Article 63 of the Political Constitution of Colombia, in the framework of what is established in Law 70 of 1993, especially in Article 5 of Decree 1745 of 1995 compiled in Decree 1066 of 2015.
- The legal representatives or the delegate of the grassroots organizations, organizational forms, and expressions of Black, Afro-Colombian, Raizal and Palenquera communities that are registered in the Ministry of the Interior, in the Registry of Representative Institutions.

Participation requirements:

- Be of legal age (will be accredited with Identification Document and/or Birth Registry).
- Be a legal representative of a Community Council or its delegate, who in any case
 must accredit the document that authorizes for said matter, with a collective title, or
 in the process of awarding title, registered at the Municipal Mayors Office by virtue
 of what is established in numeral 1 of Art. 2.5.1.1.8 of Decree 1640 of 2020 and the

External Notification with filing number OFI2022-14088-DMI-1000 of July 8, 2022. (In any case, participation will be limited to one person per Community Council).

- Be a legal representative of a grassroots Organization, Organizational Forms and Expressions of Black, Afro-Colombian, Raizal and Palenquera communities or its delegate, who in any case must accredit the document that empowers them for said matter, be registered in the Single Public Registry of the Ministry of the Interior in accordance with the provisions of numeral 2 of Art. 2.5.1.1.8 of Decree 1640 of 2020 and the External Notification with filing number OFI2022-14088-DMI-1000 of July 8, 2022. (In any case, participation will be limited to one person by ethnic organization).
- Not have any of the causes of incompatibility and inability provided for in the Constitution and the Law.
