## ORDINANCE No. 005 OF 2017 (July 30)

# "BY MEANS OF WHICH JUNE 29 IS DECLARED THE ARCHIPELAGO OF SAN ANDRES, OLD PROVIDENCE AND KETHLEENA'S FISHERMEN DAY; AND OTHER DISPOSITIONS ARE DICTATED".

The Departmental Assembly of the Archipelago of San Andres, Old Providence and Kethleena, in use of its legal faculties, especially the ones given by the article 300 of the Political Constitution of Colombia, Law 915 of 2004, Decree 1222 of 1986, Ordinance 005 of June 11 of 2009, and other concordant regulations.

### **ORDERS**

**ARTICLE 1:** Be June 29 of each year institutionalized as Departmental day of the Archipelago of San Andres, Old Providence, and Kethleena, Seaflower Biosphere world reserve's Fishermen day.

**ARTICLE 2:** The Departmental Government, represented by the Secretariat of Fishing and Agriculture, will be responsible of programming, safeguard and carry out all activities allusive to this day, considering all appointed in this Ordinance.

**PARAGRAPH 1.** Associations, Organizations, Cooperatives and other Entities dedicated to fishing activities in the Archipelago, just as those fishermen that are not linked to them, will be summoned to participate of this significative event that seeks to exalt the unconditional work that they do as transcending working people, artisans, and in general, that provide this invaluable service to our islands.

**PARAGRAPH 2.** The Departmental Assembly will monitor the total compliance of this Ordinance.

**ARTICLE 3: Validity and Derogatory:** This Ordinance and the rules, regulations, provisions, requirements, and matters established and adopted hereby shall take effect and be in full force from and after the day of its final passage, adoption, and publication. This ordinance hereby derogates all former regulations that may be contrary to it.

Approved at the Hall of Sessions of the Honorable Departmental Assembly, during its ordinary session on July 30<sup>th</sup> of 2017.
