## ORDINANCE Nº 006 (March 7, 2016)

## "BY MEANS OF WHICH MEASUREMENTS ON THE MANAGEMENT OF TOURIST FLOW ARE ADOPTED".

The Departmental Assembly of San Andres, Providence and Kethleena, in exercise of its legal faculties and, especially those granted by the articles 2 and 4 of the Article 300 of the Political Constitution of Colombia (Constitución Política de Colombia); numeral I of Article 62 of Decree Law 1222 of 1986 and Article 32 of Decree 2762 of 1991.

## **ORDERS:**

ARTICLE 1. The literal a of Article 260 of Ordinance 020 of 2006 be modified, and shall state:

a) when ships or private aircrafts and air or sea transportation companies move people towards the Archipelago whose stay on the islands surpasses (12) hours as tourist or temporary residents.

ARTICLE 2. The Article 262 of Ordinance 020 de 2006 be modified, and shall state:

"The Tourist Card fare and the contribution to the use of tourist public infrastructure is fixed to ninety nine thousand pesos (\$99.000.00), or to its equivalent in US Dollars according to the current exchange rate.

This fare is distributed as it follows: seventy five thousand pesos (\$75.000.00) for the Tourist Card and twenty four thousand pesos (\$24.000.00) for the contribution to the use of tourist public infrastructure.

ARTICLE 3. A paragraph be added to the Article 267 of Ordinance 020 of 2006:

"PARAGRAPH 3: The Tourist Card fare must be included in the tourist package, air or sea tickets, or in any other document of transportation towards of the Archipelago and could not make part of other taxes, rates or contribution liquidation".

**ARTICLE 4.** The Government will implement tools, processes, and obligatory electronic procedures to guarantee an adequate control and registration of the access and stay of tourist and residents, in efficiency and security conditions.

**ARTICLE 5.** The Departmental Administration will implement a security system in the Tourist Card that allows its adequate control and a very reduced forgery rate.

ARTICLE 6. The Governor can make the necessary budgetary modifications and adjustments to implement the adopted measures in the ordinance hereby.

ARTICLE 7. The ordinance hereby goes into effect from the moment it is sanctioned and published.
