ORDINANCE Nº 014 OF 2016 (November 09)

"BY MEANS OF WHICH ORDINANCE 016 OF 2006 IS MODIFIED AND OTHER DISPOSITIONS ARE DICTATED".

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of its legal and constitutional faculties, especially the ones given by the Article 300 of the Political Constitution of Colombia; the Decree 1222 of 1986, the Ordinance 005 of 2009 and other concordant laws.

ORDERS

ARTICLE 1. Be modified the Article 1 of Ordinance 016 of 2006, and shall state: Be created the award: "Seaflower Biosphere Reserve of the Departmental Government -Good military man, good police man, good servant or public servant, good citizen, and good raizal citizen", to exalt the workers, the Armed Forces, the National Police force, and public servants that are distinguished by their customer service, care, responsibility and compliance of their constitutional and legal duties or with the implementation of the Departmental Government's projects and programs, of the Armed Forces and the National Police force in civil coexistence, security, tranquility, and public sanitation; in tourism and the protection of the Raizal people's culture; in traffic, preservation of public space and, primarily, in actions or initiatives for the sustainability of the Global "Seaflower" Biosphere Reserve. Equally, to exalt the citizens in general and to the citizens of the Raizal ethnic people that are distinguished by their management, tasks, collaboration, initiatives and quick measures for social benefit of the islander community; their solidarity, integrity, participation and collective responsibility; civilian coexistence, embellishment, decoration and preservation of the insular environment and the culture of the Raizal people.

ARTICLE 2. Be modified the article 3 of the Ordinance 016 of 2006, and should state: the award it is being referred to in this Ordinance, and will hold a map of the Archipelago of San Andres, Providence and Kethleena in relief, with its three islands and also the words (also in relief) "SEAFLOWER BIOSPHERE RESERVE", and contouring it, GOOD MILITARY PERSON or, GOOD POLICE OFFICER or, GOOD SERVANT or GOOD CITIZEN or GOOD RAIZAL CITIZEN and will be awarded once in each of the mentioned categories.

ARTICLE 3. Be modified the Article 4 of the Ordinance 016 of 2006, and shall state: A Board composed by the Governor and Government Secretaries, Public Services and

Environment and General; will determine in each case, that members of each of the components of the Armed Forces; of the National Police force; workers of public servants, of the citizens in general and Raizal ethnic people citizens; will be deserving of the Departmental distinction; having previously reviewed they curriculum vitae and activities done in the Archipelago, in the exercise of their functions and in consideration to what is stipulated in the Article 1 of this Ordinance, during the respective year.

ARTICLE 4. Be modified the Article 5 of Ordinance 016 of 2006, and shall state: The award mentioned in the Article 1 of this Ordinance, will be imposed each year during the anniversary and onomastic of the different components of the Armed Forces and the National Police forces stationed in the Department, during the Patron festivities in each of the islands of the Archipelago in the case of the workers or public servants and during the remembrance of the Seaflower Biosphere Reserve Departmental day, on November 10 each year; in the case of the Insular society citizens, just as the Raizal ethnic people citizens. All this, will happen in a solemn ceremony in the dependency or campus or the place where each of the component or public dependencies decide for that very special day.

ARTICLE 5. The ordinance hereby goes into effect from the moment it is sanctioned and published.
