ORDINANCE Nº 025 OF 2016

(November 30)

"BY MEANS OF WHICH SOME SPECIAL PAYMENT CONDITIONS TO THE PROPERTY AND COMMERCE TAXES ARE ESTABLISHED AND INDUSTRY CONTRIBUTORS OF SAN ANDRES ISLAND".

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of its legal faculties, especially the ones given by the numeral 5 of article 300, article 310 and numerals 3 and 4 of article 313 of the Political Constitution of Colombia, numeral 7 of article 60 of Decree 1222 of 1986, article 32 of Law 136 of 1994, Lay 551 of 2012, article 57 paragraph 7 of Law 1739 of 2914, and concordant regulations.

ORDERS

ARTICLE 1. To establish the following special payment conditions for defaulting contributors of the Property, Notices and Boards and Industry and Commerce taxes of San Andres island:

- 1. To grant the 80% discount to moratorium interests of the property tax for terms 2015 and previous, to the defaulting contributors that updates their payment of the property, notices and boards taxes from December 1 to December 30, 2016.
- 2. To grant the 80% discount to moratorium interests of the Industry and Commerce, and Notices and Boards taxes of terms 2015 and previous, to the defaulting contributors that update their payment of these taxes, from December 1 to December 30, 2016.

ARTICLE 2. At the Secretariat of Finance mechanisms will be created to recover the past due portfolio, granting discounts over interests and penalties to the contributors; invite all the property owners that are behind in their payment of taxes for terms 2015 and previous, to pay their debt with a discount of the 80% over the total of moratorium interests, and past due penalties.

If payment is done within the dates established, this way:

FROM	UNTIL	DISCOUNT	
December 1, 2016	December 30, 2016	80%	

PARAGRAPH 1. To benefit from these incentives, the total amount of the tax by fiscal term must be paid and it will not apply for installment payment.

PARAGRAPH 2. The contributors can be benefitted if they are behind in their payment because of past due penalties and Moratorium interest over the Unified Property Tax, Industry and Commerce, and Notices and Boards taxes.

PARAGRAPH 3. In no case will be subscription to payment agreements be accepted over the discounts, that have payment agreements, or coercive collection processes.

PARAGRAPH 4. Those who have payment agreements will not have the right to the benefit if that agreement doesn't contemplate interests for late payment, and will only have access to the benefit when up to date with previously agreed obligations.

ARTICLE 3. The Government invites all citizens to leverage from this opportunity to be up to date with their obligations and avoid problems like being referred to Coercive Collection Office. Therefore, this special payment condition will be promoted and disseminated to the community.

ARTICLE 4. The payment of this tribute will allow to make a filtering of the data base to later give way to Coercive Collection processes.

ARTICLE 5. The ordinance hereby goes into effect from the moment it is sanctioned and published, and it derogates all disposition contrary to it.
