ORDINANCE No. 013 OF 2017

(November 30)

"BY MEANS OF WHICH THE DEPARTMENTAL OFFICE OF WOMEN AND GENDER AFFAIRS IS CREATED".

The Assembly of the Department Archipelago Of San Andres, Providence And Kethleena, in use of the legal faculties given by the numeral 13 of Article 40, 42, and 43, and numerals 7 and 9 of article 300 of the Political Constitution of Colombia, and those in articles 4, 7, and 8 of Law 51 of 1989, approving of the "Convention on the elimination of all forms of discrimination against women" adopted by the General Assembly of the United Nations on December 18, 1979.

ORDERS

ARTICLE 1. Appoint the Governor of the Department Archipelago of San Andres, Old Providence, and Kethleena to create the Departmental Office of Women and Gender Affairs as an organism in charge of leading, managing, and coordinating policies, programs and projects established by the departmental administration for all women in the Department Archipelago of San Andres, Old Providence, and Kethleena.

ARTICLE 2. The Departmental Office of Women and Gender Affairs will have the following functions:

- a. Give support in the design, elaboration and definition of the Departmental Development Plan, just as the policies, plans, programs and departmental projects so women participation and gender perspective is included in them.
- b. Promote within the Department Archipelago the participation of women in politics, culture, family, work and social life according to the framework of international commitments acquired by Colombia.
- c. Establish controlling mechanisms over the effective application of law.
- d. Direct efforts to guarantee the free, equal and solidary access of women, according to their qualities, in the work and educational areas, social, political and economic safety.
- e. Support all different forms of association of women in the Department.
- f. Design strategies Department wise, oriented to the personal development of women.
- g. Promote all actions tending to eliminate violent and discrimination forms against women.

h. Act as a coordination area of political polices for women in all the Department, including

regional and national policies.

i. Promote and implement policies, plans, programs and projects that tend to develop women

creativity and qualities in scientific, technological, artistic and cultural areas.

j. Promote and make studies and research in coordination with other national entities that

allow the formulation of strategies for women integral care in the Department.

k. Manage resources with national and international entities to be invested in plans,

programs, and projects that seek to benefit women in the Department.

I. Promote and make campaigns related to the promotion of women's rights consecrated in

the Political Constitution.

ARTICLE 3. The Departmental Office of Women and Gender Affairs will practice the interinstitutional coordination of all plans, programs, and projects related to women in the

Department Archipelago of San Andres, Old Providence, and Kethleena and all systems of

information established for the development of policies oriented to women will be under its

command.

PARAGRAPH 1. The Departmental Government will make all modifications relevant to

structure and employee list of the Departmental Administration, to make it suitable to the

requirements made.

PARAGRAPH 2. Appoint the Governor of the Department Archipelago to adopt the action plan that is required to develop a real public policy for women of the Department Archipelago

of San Andres, Old Providence, and Kethleena.

ARTICLE 4. Appoint the Governor of the Department Archipelago to make all budgetary

adjustments and reassign to the Departmental Office of Women and Gender Affairs the budgetary rubrics that may be necessary without affecting the expenditure limit according to

the law.

ARTICLE 5. The ordinance hereby derogates all disposition contrary to it and goes into

effect from the moment it is sanctioned and published.
