PROCESO DE TRÁMITE DE INCIATIVAS Y PROPOSICIONES

ORDINANCE No. 014 OF 2017

(December 26)

"BY MEANS OF WHICH THE MUNICIPAL ANIMAL SHELTER IS CREATED, AND PRO TEMPORE POWERS ARE GRANTED TO THE GOVERNOR".

The Assembly of the Department Archipelago Of San Andres, Providence And Kethleena, in use of the legal faculties given by the numeral 9 of Article 300 of the Political Constitution of Colombia,

ORDERS

- **ARTICLE 1.** Be the "Municipal Animal Shelter" established as the place where animals that are found in public ways, or in private properties, and that no owner is known, considering the land use planning.
- **ARTICLE 2.** Be fixed a right to the animal shelter of 5 legal minimum income wage to each animal, by day or fraction of day, and be created the budgetary rubric of animal shelter rights and expenditures by the use of the shelter in which citizens must deposit.
- **ARTICLE 3.** Be created the fee for Use Expenses of the Municipal Animal Shelter, which will be adjusted annually through a decree by the Departmental Government that will be collected in the Budgetary Rubric of use expenses rights of the Animal Shelter and expenses derived from the use of the Animal Shelter in which citizens must deposit.
- **ARTICLE 4.** The Secretary of Mobility will order the investigation and start the sanctioning administrative procedure according to the Article 97 of the Administrative Procedure and Administrative Contentious Code (Código de Procedimiento Administrativo y de lo Contencioso Administrativo) to the owner or person in charge of the animal that is taken to the Animal Shelter due to being loose or stranded on the public way, in order to give it back after paying the Shelter rights fee and derived expenses.
- ARTICLE 5. Appoint the government to issue the Regulatory Decree for the Municipal Animal Shelter that includes, at least, the holding time of the animals in the Animal Shelter, delivery procedure in a deposit form, delivery procedure in adoption form, delivery procedure of wild animals to CORALINA, euthanasia procedure and others needed to comply with its objectives and goals.
- **PARAGRAPH.** For all legal effects, the pro tempore powers granted to the Governor will last for three months.
- **ARTICLE 6.** The ordinance hereby derogates all disposition contrary to it and goes into effect from the moment it is sanctioned and published.
