DECREE No. 0176
(APRIL 25 2016)

"Whereby the native islander community is convened for the election of their representatives of the Raizal Community in the Directive Board of the Bureau of Circulation Control and Residence of the Departmental Archipelago of San Andres, Providence and Kethleena, in accordance with Decree 2762 1991"

The Governor of the Departmental Archipelago of San Andres, Providence and Kethleena, in use of his legal faculties and in particular, the internal rules of the Office of Control, Circulation and Residence - OCCRE -, and

CONSIDERING

The period to carry out the office as Representative of the Raizal Community for San Andres and Providence in the Directive Board of the OCCRE is three (3) years, in accordance with Article 6 of the Rules of Procedure of that entity.

That corresponds to the Departmental Administration to organize, coordinate and implement the elections to elect representatives of the Raizal Community of the Departmental Archipelago of San Andres, Providence, and Kethleena for the Directive Board, in coordination and with the support and advice of the Civil Registry.

That in merit of the above,

DECREE

ARTICLE ONE: Convene the Raizal Community of the Departmental Archipelago of San Andres, Providence, and Kethleena, to elect their representatives to the Directive Board of the Office of Circulation Control and Residence — OCCRE

REGISTRATION OF CANDIDATES: Those who meet the following requirements may register:

- a) Be Raizal; condition duly accredited with the definitive OCCRE's Card.
- b) Be eighteen (18) years old.

ARTICLE TWO: DATE, PLACE AND REGISTRATION DOCUMENTS: Candidates to be elected as representatives of the Raizal Community of the Archipelago, must registered personally from April 26 to May 10 of 2016 between 8:00 a. m. to 5:00 p. m., at the OCCRE's office in San Andres as well as in Providence Island, presenting those documents demonstrating compliance with the requirements mentioned in the previous article along with two (2) 2x 2.5 cm size photos in black and white and matte paper with completely white background.

The candidate to be registered must show up with two witnesses.

On May tenth (10th) from 5:00 p. m. until 6:00 p. m. they will carry out the lottery pick and allocation number, and identification of candidates to participate in the election process. Following this, within three (3) working days, the verification process and lack of ineligibility and incompatibility of those registered will be carried out.

Continuation Decree No. 0176 of April 25, 2016

PARAGRAPH: The Native Islanders of San Andres or Providencia whose card have been issued in a different place as the one indicated on the respective card, can vote in such place through a certificate issued by the OCCRE's Office by a special table which will be located at each voting sites such as: Sunrise Park, Brooks Hill, El Rancho School, and in Providencia on the first floor of Hotel Aury in front of the Registrar's Office.

Likewise, those who do not appear on the list (Electoral Census) or present inconsistencies with their documentation may vote on this table with prior comparison and verification with the card issuing system that the Office of Circulation Control and Residence OCCRE hold.

ARTICLE THREE: ELECTORS AND REQUIREMENTS: When voting, citizens must present their OCCRE's Card to demonstrate their Raizal status and be eighteen (18) years of age, attested by an Identification Card (Cedula).

ARTICLE FOURTH: Elections to choose the representatives of the Raizal Community of San Andres and Providencia to the Directive Board of OCCRE, will take place on May 18, 2016 between 8:00 a. m. and 4:00 p. m. at the Sunrise Park, Brooks Hill and El Rancho School, and in Providencia Island, on the first floor of the Old Aury Hotel, in front of the Special Registry Office.


PARAGRAPH: The process will take place at polling stations in which they will establish a plural number of voters of 1000 organized chronologically according to the identification document. The scrutiny, count or recount of votes in case of complaints, will be made immediately at the different tables or at those where the problem is, being competent to do so, jurors of the table or the delegates of the Registrar's office, and officials of the OCCRE'S Office, in each case.

ARTICLE FIFTH: The present Decree is in force as from the date of issue.


