## DECREE

ARTÍCLE FIRST: AMEND the date to carry out the election of the Director of the Office of Circulation Control and Residence of the Departmental Archipelago of San Andres, Providence and Kethleena –OCCRE; Established in the Third Article of Decree 0231 of June 2<sup>nd</sup>, 2016.

ARTÍCLE SECOND: Set as date to carry out the election of the Director of the Office of Movement Control and Residence of the Departmental Archipelago of San Andres, Providence and Kethleena -OCCRE, on June 28th, 2016.

**ARTICLE THIRD:** GIVE full force to the rest of the articles contained in Decree No. 0231 of June 2<sup>nd</sup>, 2016.
