**DECREE No. 0334**

(August 18, 2016)

*"Whereby it is provisionally implemented parking areas or parking for automotive terrestrial public transportation vehicles, "taxi type" and other provisions are taken."*

*THE GOVERNOR OF THE DEPARTMENTAL ARCHIPELAGO OF SAN ANDRES, PROVIDENCE, AND KETHLEENA, in use of his Legal and Constitutional Powers, especially those conferred by Law 769 of 2002, Law 1383 of 2010, Law 47 of 1993 and,*

**CONSIDERING**

In the second section of Article 2 of the Constitution states that: "The authorities of the Republic are instituted to protect all persons residing in Colombia, in their lives, honor, property, beliefs and other rights and freedoms, and to ensure compliance with the social obligations of the State and individuals" ..., hence the State must ensure security, peace and collective well-being and for that purpose, prohibit, condition and restrict transit and transportation.

That Article 24 of the Constitution, developed by Article 1 of Law 769 of 2002, as amended by Article 1 of Law 1383 of 2010, stipulates that: "Every Colombian has the right to move freely throughout the National Territory, but subject to intervention and regulations of authorities to ensure the safety and convenience of the inhabitants, especially pedestrians and physically and mentally disabled, for the preservation of a healthy environment and protecting the common use of public space".

*That according to paragraph 3 of Article 6 of Law 769 of 2002, National Code of Land Transit corresponds to the Mayors within their respective jurisdiction to issue traffic rules "Mayors within their respective jurisdiction shall issue rules and take necessary measures for the better management of the movement of people, animals and vehicles on public roads subject to the provisions of this code"*

*That Article 119 ibid states: "(...) the Transit Authorities within their jurisdiction territory, may order ... the demarcation of areas, placement or removal of signs, or prevent, limit or restrict transit or parking of vehicles on certain roads or public spaces.*

That it is necessary to allow parking or temporary parking of taxis on some roads of the Island, in order to thereby provide a better service to the citizens of our Islands, illustrious visitors and National and International tourists-until favorably culminating the implementation of Decree 0354 of December 20, 2007 - or the Departmental Road Plan.

That according to Article 8 of Law 47 of 1993, the Governor of the Departmental Archipelago of San Andres, Providence and Kethleena, exercises on the Island of San Andres, the role of Mayor.

That Taxi drivers cannot vary nor exceed the number of vehicles or authorized areas.

That taxi drivers must be properly uniformed and with their identification in order to fully established their identity.

Those taxi drivers who use the particular areas stated here will compulsorily attend the training courses stated by the Departmental Transit Agency, without excuse to revoke the authorization.

### DECREE

**ARTICLE FIRST:** Authorize the temporary Parking of passenger cars "Taxi" in the following numbers and areas:

- **Sol Caribe Centro Hotel:** Up to four (4) taxis on the Colon Avenue
- **Casa Blanca Hotel:** Up to three (3) taxis on the Costa Rica Avenue  
And two (2) on the Colon Avenue
- **Bahia Sardina Hotel:** Up to four (4) taxis on the former Colegio  
Modelo Adventista street
- **Tiuna Hotel:** Up to four (4) taxis on the Duarte Blum  
Avenue
- **Casa Dorada Hotel:** Up to four (4) taxis on the Costa Rica Avenue
- **San Andres Caribbean Hotel:** Up to four (4) taxis on the Colon Avenue
- **Verde Mar Hotel:** Up to three (3) taxis on the 20 de Julio  
Avenue
- **Galaxia Hotel:** Up to three (3) taxis on the Costa Rica Avenue
- **Tres Casitas,  
Decameron los Delfines  
Lord Pierre and El Dorado Hotels** Up to eight (8) taxis on the Colombia Avenue
- **Surtimar Supermarket:** Up to four (4) taxis on the Americas Avenue
- **Taxis Station Providencia  
Avenue-Pathway** Up to four (4) taxis on the Colon Avenue
- **Super Exitto Supermarket:** Up to three (3) taxis on the Colon Avenue
- **Caribe Sea Flower Hotel:** Up to two (2) taxis on the Americas Avenue  
(On the north side of the Barracuda Park)
- **Newball Avenue Taxi Station:** Up to three (3) taxis on the Newball Avenue
- **Sunrise Beach Hotel:** Up to four (4) taxis on the Newball Avenue

**Paragraph:** It corresponds to the Secretariat of Transportation to make immediate demarcations in order that they respect the smallest turning radius for normal traffic circulation.

**ARTICLE SECOND:** The Secretariat of Mobility together with the National Police will carry out the necessary pedagogy.

**ARTICLE THIRD:** The present is in force as from the date of its publication and repeals the provisions of territorial character that are contrary.
