ORDINANCE No. 011 OF 2017
(November 30)

**"BY MEANS OF WHICH IT IS SOUGHT THAT THE PUBLIC TRANSPORTATION
(BUSES) INCLUDE IN THEIR ROUTES THE SECTIONS OF ORANGE HILL, LITTLE
HILL, NATANIA AND RED GROUND".**

The Assembly of the Department Archipelago Of San Andres, Providence And Kethleena, in use of the faculty given by the numeral 12 of Article 300 of the Political Constitution of Colombia.

ORDERS

ARTICLE 1. Order the Governor of the Department Ronald Housni Jaller, through his Secretariat of Mobility, make arrangements necessary to allow the inclusion of the sections Orange Hill, Little Hill, Natania, and Red Ground, in the routes of the public transportation service (bus).

ARTICLE 2. Order the Governor Ronald Housni Jaller to guarantee the inhabitants of these sections a traditional means of transportation (public service buses) that cover their needs of mobility.

ARTICLE 3. Order the Governor Ronald Housni Jaller take the necessary measurements to comply with that established in Article 1 and Article 2 of this Ordinance.

PARAGRAPH. The Departmental Government will implement what is necessary to elaborate a road study prior to the implementation of a route that fosters especially the provision of service of the public transportation service for the Orange Hill, Little Hill, Natania, and Red Ground sections, and their surroundings.

ARTICLE 4. The ordinance hereby derogates all disposition contrary to it and goes into effect from the moment it is sanctioned and published.
