ORDINANCE No. 010 OF 2017
(November 30)

"BY MEANS OF WHICH A MODIFYING ADDITION IS MADE TO ORDINANCE 018 OF 2012 AND CONMEMORATIVE MONUMENTS ARE MADE FOR CAPTAINS, OFFICIALS, SAILORS, AND CITIZENS THAT ARE MISSING OR DEAD IN THE CARIBBEAN SEA, AND SPECIALLY IN WATERS OF THE DEPARTMENT ARCHIPELAGO AS A LIMITING AND ETHNIC REGION WITH CENTRAL AMERICA AND THE ANTILLAS".

The Assembly of the Department Archipelago Of San Andres, Providence And Kethleena, in use of the faculty given by the Article 300, numeral 2, of the National Constitution; Article 60, numeral 3 and Articles 72, 73, and 74 of Decree 1222 of 1986; Article 4, literal b and j, and the Articles 7 and 10, literal f of Law 47 of 1993, and Ordinance 005 of 2009 (the Departmental Assembly Internal Regulation). And, considering the established in Article 1, literal a) and the Article 5, literal a) of the Agreement 169 with the OIT, about Indigenous and Tribal People in independent countries; just as in Articles 7, 8, 70 and 150 of numeral 5) of the Political Constitution of Colombia; in Sentences 086 of 1994 and 053 of 1999, and in Law 1 of 1972 and the numeral 1) of Article 1 of Decree 1946 of 2013, regulated in Law 10 of 1978 and Law 47 of 1993 and other concordant regulations.

ORDERS:

ARTICLE 1. Be added only 1 paragraph to Article 3 of Ordinance 018 of November 30 of 2012, and it shall state: **PARAGRAPH:** Be the Departmental Government authorized to raise a monument in a public space, plaza, court or appropriate area on the islands of San Andres and Old Providence; in memory of, remembrance, and posthumous homage to the Captains, Officials, Sailors, Crew, and Citizens in general who have disappeared or died in the Caribbean Sea and, especially, in the seas of the Department Archipelago was a bordering and ethnic region with Central America and the Antillas or the Sea Territory of the Insular Territories of Colombia in the Western Caribbean.

ARTICLE 2. The ordinance hereby goes into effect from the moment it is sanctioned and published.

Approved at the Hall of Sessions of the Honorable Departmental Assembly, during its extraordinary session on November 30th of 2017.
