**ORDINANCE No. 007 OF 2017**  
*(August 7)*

**"BY MEANS OF WHICH IT IS CREATED A BUDGETARY RUBRIC TO COLLECT THE FINES IN SAN ANDRES ISLAND, CONTEMPLATED IN THE NATIONAL CODE OF POLICE AND COEXISTENCE, LAW 1801 OF 2016".**

**THE HONORABLE DEPARTMENTAL ASSEMBLY OF THE ARCHIPELAGO OF SAN ANDRES, OLD PROVIDENCE AND KETHLEENA**, in use of its legal faculties, especially the ones given by the article 300 and numeral 5 of 313 of the Political Constitution of Colombia, in accordance to Article 8 of Law 47 of 1993, and the Article 185 of the National Code of Police and Coexistence

**ORDERS**

**ARTICLE 1:** Create the budgetary rubric to guarantee the collection of the fines issued by the police authorities in San Andres island, by implementing the National Code of Police and Coexistence, Law 1801 of 2016.

**ARTICLE 2:** This Ordinance hereby shall take effect and be in full force from and after the day of its final passage, adoption, and publication; and it derogates all former regulations that may be contrary to it.
