ORDINANCE No. 004 OF 2017 (July 30)

"BY MEANS OF WHICH IT IS SOUGHT TO EXALT AND DIGNIFY THE FAIR TABLE ACTIVITY AS A PART OF OUR GASTRONOMY, CULTURE, AND TRADITION; AND OTHER DISPOSITIONS ARE DICTATED".

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of its constitutional and legal faculties, especially the ones given and decreed by the articles 300 of the Political Constitution of Colombia, in accordance to Law 47 of 1993, Law 1037 of 2006, and Ordinance 005 of June 11 of 2009.

ORDERS

ARTICLE 1: Be the Governor of the Department Archipelago authorized to implement strategies and create public policies, plans and programs to support and promote the Fair Tables activity.

ARTICLE 2: Be the Governor obliged to carry out activities that seek to promote the Fair Tables local, national, and internationally wise as a gastronomical, cultural and traditional activity of our island.


ARTICLE 3: Be the Departmental Government obliged to manage all necessary resources to adapt the physical infrastructure of the Fair Tables stands in the Department Archipelago.

ARTICLE 4: Be the Governor obliged to make necessary actions to make the Fair Tables a part of the Colombian Gastronomical Events Network.

ARTICLE 5. Within the framework of the Cultural Patrimony month, be mandatory to exalt and acknowledge the Fair Tables as part of our culture and tradition.

ARTICLE 6. This Ordinance and the rules, regulations, provisions, requirements, and matters established and adopted hereby shall take effect and be in full force from and after the day of its final passage, adoption, and publication. This ordinance hereby derogates all former regulations that may be contrary to it.

Approved at the Hall of Sessions of the Honorable Departmental Assembly, during its ordinary session on July 30th of 2017.
