ORDINANCE N° 001 OF 2016
(January 14)

“BY MEANS OF WHICH THE INTERNAL REGULATIONS OF THE ASSEMBLY OF SAN ANDRES, OLD PROVIDENCE AND KETHLEENA, ORDINANCE 005 OF 2009, ARE PARCIALLY MODIFIED”.

The Departmental Assembly of San Andres, Old Providence y Kethleena, in use of its legal faculties and, especially those conferred by the articles 2, 5, 7, 8, 13, 44, 68, 300 and 311 of the Political Constitution of Colombia, the legislative act 02 of 2015, Law 915 of 2004; the Decree 1222 of 1986, Ordinance 005 of June 11 of 2009 and other concordant rules.

ORDERS:

ARTICLE 1: Be modified Article 61 of Ordinance 005 of 2009, that shall state:

The Departmental Assembly will choose a General Secretary for a year term, who could be reelected after public summoning accordingly to the Law.

The election of the General Secretary, their term and possession day will take place as it follows:

1. For the First year of sessions, the election will be held the second day of January and will take possession before the President of the Corporation.
2. For the Second, Third and Fourth year, the election of the General Secretary will be held the same day of President and Vice-president elections. They will take possession the second day of January of the Second, Third and Fourth year before the new President.

ARTICLE 2: The Article 240 of Ordinance 005 of 2009 shall state:

The election of Comptroller General of the Department will be preceded by a public call regulated by Laws respectively.

ARTICLE 3 TRANSITORY: For year 2016, once ordinary sessions are started, the Departmental Assembly is empowered to proceed to the call, selection and election of its public servants, those who legislative act 02 of 2015 refers to, once the hereby legislative act is firm.




