

**ORDINANCE N° 008**  
**(March 7, 2016)**

✓ **“BY MEANS OF WHICH THE ORDINANCE 006 OF 2015 ABOUT THE TAX INCENTIVE CALENDAR IN THE UNIFIED PROPERTY TAX, INDUSTRY AND COMMERCE, NOTICES AND BOARDS IS MODIFIED”.**

THE DEPARTMENTAL ASSEMBLY OF SAN ANDRES, OLD PROVIDENCE, AND KETHLEENA, in exercise of its legal and constitutional faculties, especially those granted by the numeral 9 of the Article 300 of the Political Constitution of Colombia (Constitución Política de Colombia) and numeral 5 of Article 62 of the Decree Law 1222 of 1986; and the norms consistent with it

**ORDERS**

**ARTICLE 1.** Be the Governor of the Department Archipelago of San Andres, Old Providence and Kethleena authorized to prorogate the tax incentives established by the Ordinance 005 of 2015.

**ARTICLE 2.** The Article 2 of Ordinance 006 of December 9 of 2015 will state:

All contributors that to December 31 of 2015 certify compliance to the unified property tax, industry and commerce taxes, and boards and notices, will have discounts provided early payment over the taxes mentioned for the term 2016, if they pay within the established dates in the following tax incentive calendar:

| SINCE                          | UNTIL                         | DISCOUNT |
|--------------------------------|-------------------------------|----------|
| JANUARY 1 <sup>ST</sup> , 2016 | MARCH 31 <sup>ST</sup> , 2016 | 15%      |
| APRIL 1 <sup>ST</sup> , 2016   | MAY 31 <sup>ST</sup> , 2016   | 10%      |
| JUNE 1 <sup>ST</sup> , 2016    | JULY 30 <sup>TH</sup>         | 5%       |

**Paragraph 1:** To benefit from these incentives, the total amount of the tax by fiscal validity must be paid and will not apply for bonuses.

**Paragraph 2:** To settle all overdue interests of the contributors that have not paid their taxes for the term 2016: Unified property tax, industry and commerce, notices and boards, motor vehicles; that pay these taxes before July 1<sup>st</sup>, 2016.

**Paragraph 3:** The contributors that do not comply with the duty of paying for the term 2016 until the due date established by this calendar, will declare and pay sanctions that the tributary statute establishes for this effect.

**ARTICLE 3.** The ordinance hereby goes into effect from the moment it is sanctioned and published and derogates all dispositions that opposes it.
