ORDINANCE No. 009 OF 2017
*(November 30)***"BY MEANS OF WHICH MAY 16 OF EACH YEAR IS DECLARED AS THE DEPARTMENTAL DAY OF REMEMBRANCE AND SOLIDARITY WITH THE VICTIMS OF INSULAR VIOLENCE, CRIME AND INSECURITY; AND OTHER DISPOSITIONS ARE DICTATED".**

The Assembly of the Department Archipelago Of San Andres, Providence And Kethleena, in use of the faculty given by the Article 300, numeral 2, of the National Constitution; Article 4, literal a, b and y, and the Article 10, literal f of Law 47 of 1993; Article 60, numeral 3 and Articles 72, 73, and 74 of Decree 1222 of 1986 and the Departmental Assembly Internal Regulation, Resolution 005 of 2009.

ORDERS

ARTICLE 1. Be May 16, of each year, established as "***Departmental remembrance and solidarity with insular victims of violence, crime, and insecurity day***" in the Archipelago of San Andres, Old Providence, and Kethleena.

ARTICLE 2. The inhabitants and visitors of the Department Archipelago, official entities, ecclesiastic institutions, companies, corporations and establishments of the ethnic territory, in a sign of morning and during that day, will fly at half-mast the Colombian Flag, the Department's Flag and Municipalities included in it, and its own entities and institutions, in mourning and solidarity with the victims of insular violence, crime, and insecurity.

ARTICLE 3. For the whole "***Departmental remembrance and solidarity with insular victims of violence, crime, and insecurity day***", the Departmental Administration and the Honorable Corporation popularly elected, will pay solemn homage in consideration to the unfortunate event in May 16, 2017, when the raizal merchant and businessman Saulo Jackson Aguilar was murdered, and in memory of and special remembrance to the homicide of the 15-year-old boy Jhonatan Gutierrez Beltran, just as the murder of Alirio Rodriguez Arias, and his family, as other obscure felonious events and incidents that have had a considerably transcendence and painful significance to the families of the Insular society residents just as to the families of the Ethnic Raizal People of the Department Archipelago, now the World's Biosphere Reserve Seaflower.

ARTICLE 4. Construction of the instrument of Remembrance. The Departmental Administration, in team with the Ombudsman's Office and support from the Human Right Organizations and Academy, will put together a list of the names of the citizens of the islands that have been murdered or forcedly disappeared during the last years in land and maritime territory of the Archipelago, just as the marking of the different facts, tragic and historic

events that have intrinsically affected the ancestral subsistence and daily life of people and their families in these insular latitudes, their values and good practices, faith and characteristic spirituality, their customs, and kind help towards their fellows; and where the respect for others, defense of human life, fear of God and abiding to land and divine laws was considerably and significantly predominant.

ARTICLE 5. Significant Monument. The Departmental Administration, in team with competent authorities, and in an effective and real manner, will build a monument or significant sculpture in the place where the community agrees with the purpose of paying homage of this characteristic day of remembrance and solidarity with insular victims of violence, crime, and insecurity. "Saulo's Day"

ARTICLE 6. Public Policy. Be the Departmental Government entitled to develop a public policy to prevent, contain, and reduce the commission of all kinds of crime in the Department Archipelago of San Andres, Old Providence, and Kethleena, in team with the competent and security authorities.


ARTICLE 7. Sanction and Promulgation. The ordinance hereby goes into effect from the moment it is sanctioned and published.
