ORDINANCE Nº 021 OF 2016
(November 29)

“BY MEANS OF WHICH THE GOVERNOR OF THE DEPARTMENT ARCHIPELAGO IS GIVEN FACULTIES TO IMPLEMENT THE TAX CALENDAR, TAX INCENTIVES OVER THE UNIFIED PROPERTY TAX, INDUSTRY AND COMMERCE, NOTICES AND BOARDS”.

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of its legal faculties, especially the ones given by the numeral 5 of the article 300, and article 310 of the Political Constitution of Colombia, the numeral 7 of article 60 of Decree 1222 of 1986, and concordant rules.

ORDERS

ARTICLE 1. Be given extraordinary faculties to the Governor of the Department Archipelago of San andres, Old Providence, and Kethleena, for the implementation of tax incentives.

ARTICLE 2. For contributors that are up to date to December 31 of 2016 on the Unified Property Tax, Industry and Commerce, Notices and Boards, discounts will be given for their promptly payment on term 2017, if their payment is made within the established dates in the following tax calendar:

SINCE	UNTIL	DISCOUNT
January 1 st , 2017	February 28 th , 2017	15%
March 1 st , 2017	April 30 th , 2017	10%
May 1 st , 2017	June 30 th , 2017	5%

PARAGRAPH 1. To benefit from these incentives, the total amount of the tax must be paid by fiscal term and it will not apply for installments.

PARAGRAPH 2. Settle interest on arrears to the contributors that have not paid term 2016 of the taxes: Unified Property, Industry and Commerce, Notices and Motorized Vehicles, that pay these taxes after June 30th, 2017.

PARAGRAPH 3. The contributors that do not comply with their duty to pay term 2016 to the last due date established by this calendar, will declare and pay penalties that the Tax Statute establishes for this effect.

PARAGRAPH 4. The self-declarable taxes of Industry and Commerce and Motorized Vehicles Tax, that are declared untimely after June 30th, 2017, will have to pay a penalty for untimely payment, established in the National Tax Statute.

ARTICLE 3. Urge the Department's Government so, starting January 1st, 2017, mass dissemination campaigns to contributors are done in relation to the tax calendar that will be in effect in the Department Archipelago during term 2017.

ARTICLE 4. When the National Government gives faculty to the Territorial Entities to apply special conditions for taxes and contributions according to their competency, it will directly abide by it.

ARTICLE 5. The ordinance hereby goes into effect from the moment it is sanctioned and published, and it derogates other disposition that are contrary to it.
