ORDINANCE N° 022 OF 2016 *(November 29)*

"BY MEANS OF WHICH THE HONORABLE DEPARTMENTAL ASSEMBLY AUTHORIZES THE GOVERNOR OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, OLD PROVIDENCE, AND KETHLEENA TO COMPROMISE EXTRAORDINARY FUTURE VALIDITIES".

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of its legal faculties, especially the ones given by the numeral 5 of the article 300, the articles 345 and 352 of the Political Constitution of Colombia, the National Decree 111 of 1996, the Law 819 of 2003 and Law 1483 of 2011.

ORDERS

ARTICLE 1. Authorize the Governor of the Department to assume compromises of extraordinary future validities to hire the provision of School Nourishment of the Departmental Secretariat of Education with a charge to the budget of term 2017 in the following quantity and applicability:

TERM 2017: \$3.543.380.979 – THREE THOUSAND FIVE HUNDRED AND FORTY-THREE MILLION THREE HUNDRED AND EIGHTY THOUSAND NINE HUNDRED AND SEVENTY-NINE PESOS:

PARAGRAPH: The financing of the resources of 2017 will be with the resources of the school nourishing program that the National Ministry of Education assigns to the Departments, resources from the General System of Participations and its own resources.

ARTICLE 2. The Secretariat of Finance of the Department, once compromised the resources that article 1 refers to, will include in the respective annual budget the necessary assignments to cover future acquired commitments.

ARTICLE 3. Be given faculty to the Governor of the Archipelago of San Andres, Old Providence, and Kethleena to make budgetary movements that are originated in compliance of the ordinance hereby.

ARTICLE 4. The ordinance hereby goes into effect from the moment it is sanctioned and published.
