ORDINANCE Nº 024 OF 2016

(November 29)

"BY MEANS OF WHICH A DEPARTMENT'S CULTURAL AND GASTRONOMIC EVENT IS INSTITUTIONALIZED IN THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, OLD PROVIDENCE, AND KETHLEENA "THE STEW FESTIVAL".

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of its legal faculties, especially the ones given by the articles 13, 47, 54, 68, and 300 of the Political Constitution of Colombia, and in relation to Law 599 of 1990, Law 1098 of 2006, Law 47 of 1993, and Law 915 of 2004; the Decrees 860 of 2010 and 1222 of 1986.

ORDERS

ARTICLE 1. Be institutionalized in the Archipelago of San Andres, Old Providence, and Kethleena the Department's Cultural and Gastronomic Event "The Stew Festival".

ARTICLE 2. Objectives: The following are the objectives of the Department's Cultural and Gastronomic Event:

- a. To promote and encourage the cultural expressions of the Raizal Ethinc People in the Department Archipelago, in conformity with the Political Constitution of Colombia, in its Articles 7, 8, 70, and 71; Law 397 of 1997, and Law 47 of 1993, among others.
- b. To guarantee the historic prevalence of the gastronomy and representative flavors of the Raizal People, specially all related to sweets and traditional delicacies within the ancestral identity of the inhabitants of the Department Archipelago, the Residents, Visitors and Tourists that arrive to the island.
- c. To stimulate pedagogical, cultural, recreational and touristic proposals related to our flavors and aromas derived from our own special sweets, from the Raizal Ethnic People.

ARTICLE 3. In consideration to the article 18 of Law 397 of 1997; during the celebration of the Department's Cultural and Gastronomic Event "The Stew Festival", contests and awards will be held and given in relation to the preparation of these sweet and typical delicacies and other traditional dish of the Ancestral gastronomy of the Archipelago in the Western Caribbean.

ARTICLE 4. Organization, development and promotion. The date of the celebration of the Department's Cultural and Gastronomic Even "The Stew Festival" will be during Easter (Holy Week) each year. The organization and attainment of the activities related to the Departmental Event will be made by the community of the Raizal Ethnic People and its celebration, development and promotion will be responsibility of the Department's Secretariat of Culture.

PARAGRAPH: The products offered in the event cannot be commercialized.

ARTICLE 5. Be authorized the Secretary of Culture of the Department Archipelago of San Andres, Old Providence, and Kethleena to make all budgetary management that are considered necessary for the implementation of the Ordinance hereby.

ARTICLE 6. The ordinance hereby goes into effect from the moment it is sanctioned and published.
