**ORDINANCE No. 001 OF 2018**  
*(April 30)*

*"By means of which the Honorable Departmental Assembly declares the Departmental Christian Culture Integration Week in the Department Archipelago of San Andres, Old Providence, and Kethleena"*

**THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, OLD PROVIDENCE, AND KETHLEENA**, in use of its constitutional and legal faculties, especially those conferred by the article 300, Number 3, Article 19 of the Political Constitution of 1991 and Article 4, Article 6 Letter B and J of the Statutory Law 133 of May 23 of 1994.

**ORDERS**


**ARTICLE 1.** Establish permanently the last week of September as the Departmental Christian Culture Integration Week of the Department Archipelago of San Andres, Old Providence, and Kethleena.


**ARTICLE 2.** The Departmental Government will organize a cultural activities and dissemination activities related to the Departmental Christian Culture Integration Week, all to promote Christian faith unity in their different ecclesiastic expressions and guarantee Christian tourism on the island.

**ARTICLE 3.** The Departmental Government will take measures that guarantee peace and quietness in all the territory of the Archipelago of San Andres, Old Providence, and Kethleena during the celebration of the Departmental Christian Culture Integration Week.

**ARTICLE 4.** The ordinance hereby goes into effect from the moment it is sanctioned and published.
