**Answer:** The Entity has carried out several operations in different areas of the Departmental Archipelago and jointly with several authorities such as the Police, Colombian Migration, Air Force, National Navy and Army, obtaining favorable results, however, it should be noted that the National Police is not the competent authority to request the OCCRE document, since they are in charge of verifying the judicial situation of the citizen regardless of whether he or she is a permanent and/or temporary resident or not, and the Circulation and Residence Control Office, OCCRE, is the entity in charge of carrying out this verification in accordance with the provisions of Article 36 of Decree 2762 of 1991, in accordance with Article 19 of Decree 2171 of 2001.

E.S.P. warehouse, neighboring to the Clarence Lynd Newball Departmental Hospital, where the Departmental Fauna Shelter (Coso Municipal) currently operates, complies with the requirements established by the Planning Secretariat for this type of activity and with the basic requirements for its operation.

## SAFETY AND COEXISTENCE

**What is this Secretariat doing in terms of constructions of more than two floors that do not use poly-shades, or fences when they are executing their works and things fall on the street, and there are no workers around checking or doing control.**

**Answer:** One of the essential functions of the Police Inspectors, is focused on knowing in first instance the ordinary contraventions that deal with the National Police Code, Departmental Police Code, Police Manual, Citizen culture and coexistence and other special laws that regulate each case (Urban Control and Decoration, Commercial Establishments, Health, Consumer Protection, Public Space, Citizen Service).

In regards of the Urban Control, the Urban Police Inspector will know about the complaints related to construction regulations, ex officio or at the request of Planning or the interested party, that is why, once the Inspection has knowledge of constructions that do not comply with any of the obligations established in Article 135 of Literal D of Law 1801 of 2016, it proceeds in accordance with what is indicated in Article 223 of the aforementioned Law-National Code of Police and Coexistence, thus ensuring compliance with urban regulations.

It should be noted that for Dengue and other Arboviro-sis-type diseases, three types of control can be implemented; the chemical (larval and adults), biological and physical, of which emphasis has been placed on the control of mosquito larvae, and physical control is promoted through the covering of tanks, collection of useless containers, among others. It should be noted that the actions in homes represent 90% of the impact required for the prevention of Dengue, taking into account that the main breeding sites for the *Aedes aegypti* mosquito are clean water tanks.

That the application of insecticides in space or with a vehicle-mounted machine is used for contingency cases, considering that fumigation is an activity that negatively impacts the air, soil, and water, producing deleterious effects in the short, medium, and long term, as well as resistance to insecticide. It is important to point out that the use of the same insecticide, prolonged in time, produces a shift in the resistance barrier of the insects, causing from one generation to another, weak-resistant individuals, to pass to a next generation of resistant individuals, having to resort to changing the insecticide for another of greater toxicity, with the effects that this entails.

Considering the above, it is important to note that as of May 31, 2023, the Department has reported a total of five (5) cases, which places the territory in the group of Departments that do not present a Dengue alert during the validity. Given the above, it is harmful and unnecessary to apply pressure with insecticides, if this does not correspond to the epidemiological reality of the Department.

**Answer:** In effect, the sector indicated above is a small part of the pedestrian area, where the transit of motor vehicles is allowed, however, its main function or its main reason is for pedestrian use, so the drivers of vehicles that transit in this area, should always be pending for pedestrians who will have priority. Despite the presumption about traffic priority in this sector, the accompaniment of the pedagogical group of the Secretariat of Mobility has been carried out and will continue, in order to increase the knowledge of the community about road education. We will also continue with the accompaniment of the traffic agents who have the competence granted to them by Law 769 of 2002, to remove vehicles among other various measures necessary to maintain order and control of the departmental roads. However, the possibility of being able to implement or include the corresponding road signs to have clarity, the priority of pedestrian traffic in this area and that together with the accompaniment of the educational group will be studied.

- **Use proper paints on the streets because in less than three months they fade away.**

**Answer:** The paint required for road marking is a special paint with the intention of resisting the visualization of road markings for as long as possible, considering vehicular traffic and other components that will inevitably affect its appearance and sharpness. For the recent demarcation of the departmental roads, the use of this special paint was used, which meets the conditions required by the Ministry of Transportation and which, despite being a new paint technology for road signs, does not promise, like none does, its permanent durability, so proper maintenance and retouching of these demarcations will always be necessary between 3 to 8 months, depending on the variety of factors such as the amount of vehicular traffic, as well as climatic condition becomes a factor, which in the department further affects the durability of the paint due to humidity, the presence of sea salts and UV rays, which, as is common knowledge, can cause greater affectation to the appearance and sharpness of the paintings.

- **What mechanism will you implement to further support and invest in Higher Education?**

**Answer:** It is important to inform the community that the Department already has a public policy to strengthen higher education, which establishes the route for preparation, access, permanence, and successful graduation from higher education for the island population. One of the central ideas of the policy is the financing of higher and tertiary studies of the population, especially of the young population. Consequently, it is necessary to make use of the national policy to strengthen public higher education so that the island population can have access to it. It is also contemplated to continue with the allocation of resources to the departmental fund to continue benefiting students of Educational Institutions and especially those with the best achievement. Likewise, the consolidation of agreements with ICETEX to favor our students with forgivable loans for higher education, alliances with universities so that they assign special discounts for students from the islands who enter in the different academic programs they offer. In the same way, they are working with ICETEX to ensure that they support young people with living subsidy who travel to the mainland. Another form of investment that is contemplated corresponds to 5% of the direct allocations of royalty resources, in accordance with paragraph 1 of Article 40 of Law 2056 of 2020 and finally resources will be requested from the Special Assets Society - SAE, to allocate them to the higher education of our young people.

- **How many teachers attended the diploma course in April 2022 and what was its cost?**

**Answer:** It is being informed that the Secretariat of Education did not carry out any diploma course during 2022, therefore, no education resources were used for this purpose.

- **Why have teachers who are under contract has not been appointed on property? since there are more than 40 and there is a law that they must appoint Raizal teachers and they have not done so, some have been under contract for more than 6 years?**

**Answer:** Currently the Secretariat of Education does not have any teaching relationship by contract, in the case of teachers who are provisionally hired, the Secretariat of Education cannot name or link them permanently until the National Civil Service Commission opens calls for those positions. **Answer:** In accordance with the procedure established by the Single National Decree 1077 of 2015, "By means of which the Single Regulatory Decree of the Housing Sector, City and Territory is issued", for the process of urban construction license it is not required to visit the property object of the request. The foregoing and taking into account that a review of the project is carried out from the legal, urban, architectural, and structural point of view based on the documentation provided by the applicant that refers to the property, established in Resolution 1025 of 2021, issued by the Ministry of Housing, City and Territory, related to the documents that must accompany the applications for urban planning licenses and modification of current urban planning licenses.

It should be noted that within the framework of the review, the land use applicable to the project is verified and only projects that comply with it are approved.

- **Why when they authorize a repair of a two-story building, do they authorize more?**

**Answer:** The floors that are authorized have to do with those allowed in each Planning Unit.

Thus, in the example you proposed, if there is a two-story building and the norm allows 4 floors, it is feasible that the interested party request an extension license for those two more floors that the norm allows. The regulations applicable to each Island Planning Unit can be verified in the

- **What is the Social Development office doing to target or rehabilitate all the homeless on the island.**

**Answer:** From the Homeless program of the Secretariat of Social Development, a group of vulnerable people who are in this condition has been targeted, so the work team is in constant communication with them to mitigate the different situations that are associated with habitability on the street, such as:

- **Guarantee access to Health:** By means of a census list report to the Secretariat of Health, access to health is guaranteed. In the same way, the periodic visits that are made to the population and when a health situation that must be addressed is detected, the team accompanies the homeless person so they can be treated at the hospital; in the same manner the necessary orientation and corresponding accompaniment are provided when they need it.
- **Identification document:** The Secretariat is taking the corresponding steps so that all homeless people have their identification document.
